By the time you read these notes, I will have handed over to my successor, Lt Col Jonny Cray, and my time as the Commanding Officer of our fine Regiment will have come to an end.

When I wrote in the last edition of 'Out and About', I reflected on the extraordinary turmoil and uncertainty that had shrouded our

lives during the first half of the year. The firemen's strike, Op TELIC in Iraq, our delayed deployment to Canada as the OPFOR and then ongoing doubts about how long we would be away; all these and other pressures perhaps coloured our judgement of 2003 in those first six months.

However, the year ended well and I can report that the Regiment returned from Canada, with resounding accolades from our Brigade and Divisional Commanders and a public endorsement from Commander BATUS that we were the best trained Battlegroup in the British Army. Certainly, spirits were remarkably high as we arrived back in Munster in November in time for a sustained and protracted burst of Christmas festivities, before three weeks of well-earned leave. Without wishing to brag, I can state the facts about our time at the British Army Training Unit Suffield, or BATUS as it is usually known. During our six months in theatre, we fought five of the Army's front line battlegroups and 1st Mechanised Brigade; a total of 27 battles or missions, of which, according to the statistics, we won 23. OPFORs, although usually very effective (understandably so in view of how long they spend there), are not normally meant to be quite so successful! And it was fun. Just about every man had at least a week of adventure training and we all got more than our allocation of leave during the year, with plenty of opportunity to travel around the USA and Canada or

spend time with our families back at home. So, much success and much to be proud of.

My time in command is finished, and although I don't feel that I have done half the things I would like to have achieved, I do feel confident in saying that I am handing over to Jonny Cray, to whom I wish every

success, a happy, contented and professionally highly effective Regiment. As always, it comes back to people. We are 32 men overstrength, we have 135 committed recruits on our books, our retention has been good and we have plenty of good quality potential officers who want to join the Regiment. Beyond that, we have real strength and talent at all levels in the Regiment, from Trooper to Major. In our core skills of gunnery and tactics, there is none better. Pretty much everywhere, I feel that there is a real sense of pride in our achievements, pride in the Regiment, a feeling of comradeship and togetherness and a genuine esprit de corps. We have worked hard and played hard and that was all I ever wanted.

Before I finish, I would like to pay a personal tribute to our indefatigable, immensely loyal and incomparable Regimental Secretary, John Etherington and team at Home Headquarters. They do so much for us all, both serving and retired, and so much of it is unseen and so often unsung. Their experience, advice and compassion have been invaluable and I really don't know how we would manage without them.

As for me, serving in this Regiment for the last twenty three years and then commanding it for the last two has been an immense honour, pleasure and privilege and in the years ahead I will miss the Regiment and my men very much indeed – Quis Separabit and Fare Thee Well indeed.

COMMEMORATION OF EXERCISE SMASH - 4 APRIL 1944 TO BE HELD 3/4 APRIL 2004

Sixty years ago in the early morning of the 4 April 1944 the 4/7 Royal Dragoon Guards in their amphibious Valentine "DD" tanks were launched from their landing craft for a live firing rehearsal for D-Day. The weather was marginal at launch and later deteriorated resulting in the loss of six lives and six tanks. As a result, on D-Day the amphibious tanks (by then the American Sherman) were launched closer inshore than had been originally planned and in fact the 4/7th were taken right to the beach. As a result few were lost in general and the only losses to the Regiment on D-Day were due to subsequent swamping when the tide came in. There was a notable difference between the British and American loss rates of amphibious tanks on D-Day largely because the Americans launched from the original distance from shore. The difference in fire support on the beaches also caused widely different casualty rates amongst the other assault troops. The commemoration, which has been organized by Mr John Pearson and Mr Cecil Newton, is to be in two separate but linked parts:

1. On Sunday 4 April 2004, ex members of the 4/7 Royal Dragoon Guards, widows supporters and other veterans will hold a Remembrance service on the headland by Fort Henry, Studland. This will include the unveiling of a slate memorial recording the event and the lives lost. A wreath will be laid on the waters of the Bay from a Royal Marines landing craft with a bugler playing "Last Post" and "Reveille". There may then be an aircraft flypast. Fort Henry itself is the original viewing position constructed specifically for the high ranking audiences witnessing the D-Day training exercises taking place there in 1943 and 1944.
2. The other part of the event will be a military vehicle show which will be the first public appearance of the only surviving Valentine DD tank following a twenty year restoration by John Pearson. This will be over both days of the weekend of 3/4 April 2004 and will be based on the beach at the Knoll, Studland that is about a half-mile from Fort Henry. It will be driven and demonstrated at regular intervals. There will also be other wartime vehicles on display including a Churchill AVRE (Armoured Vehicle Royal Engineers), Sherman, Stuart, Sherman based Beach Armoured Recovery Vehicle, artillery and other privately owned wartime vehicles and also modern Army vehicles including Challenger 2 and Scimitar. Also in attendance will be landing craft from The Royal Logistics Corps. It is anticipated that the Valentine DD and the Churchill AVRE will be brought to the beach by landing craft. After the event, the Valentine DD will be placed on exhibition at the Tank

Saturday 3 April 2004

09.00 Carpark at the Knoll open to the public and privately owned MV's to arrive.

10.00 approx. Churchill and Valentine arrive in RLC landing craft, which are beached (*)

10.30 approx. Churchill and Valentine DD wade ashore and park with other vehicles on beach. (*)

11.00 to 18.00 Tanks are periodically displayed running and moving on sands, including embarking/disembarking once sea has receded.

Sunday 4 April 2004

09.00 approx. RLC landing craft returns. Programme similar to 3 April.

10.00 to 10.30 Veterans assemble at Middle Beach Carpark, Studland.

10.45 Veterans and standards make their way to Fort Henry. This will have to be in single file due to trees.

4/7RDG Banner, piper, and official guests form up in Middle Beach Carpark.

10.55 Official party march to Fort Henry from Middle Beach Carpark

11.00 Commemoration Service and unveiling of plaque. Wreaths to be laid. Piper plays lament

11.30 Approx. Wreath laid on waters of Bay from RM landing Craft; Last post sounded by Royal Marines bugler on Landing craft 1 minute silence Reveille sounded

12.00 Possible Flypast, number of aircraft and type to be confirmed.

RM landing craft returns Bay wreath laying party to Sandbanks ferry jetty. Veterans then invited to view vehicle display at the Knoll

15.30 Valentine, Churchill embark on RLC landing craft for return.

NB: All RLC landing craft movements and timings (*) are dependant upon tides which have not yet been ascertained. All military involvement will be subject to Operational Requirements and in addition landing craft use will be dependent upon weather. Again, weather permitting, RSM Kirkman and a diving party are planning to place a plaque on a submerged tank.

THE MEMORIAL PLAQUE STUDLAND BAY

The plaque, which is being organised by *John Pearson*, is of slate size one foot ten inches by one foot five inches high and will be mounted on a natural stone 'lectern' at Fort Henry overlooking Studland Bay. Total cost is £596.31 which will be paid by *John Pearson* less £300 donated by the Creully Club. *John* is to be most sincerely thanked for his generosity. Contributions would be welcomed and may be sent to HHQ for forwarding to Mr Pearson.

THE PENSION CREDIT

Members and widows over 60 may be entitled to claim a "top up" to their weekly income by applying for the Pension Credit, which has replaced the Income Support element of the Minimum Income Guarantee. The Pension Credit aims to guarantee a basic level of income of £102.10 pw for single people and £155.80 pw for couples.

The Pension Credit is formed in two parts: the Guarantee Credit and the Savings Credit.

A "tariff of £1 pw is taken into account for every multiple of £500 or part over the base level of £6,000 of savings. Your residence is not taken into account providing you live there. When assessing the entitlement to the Pension Credit the following sources of income are taken into account: *State Retirement Pension, Occupational Pension, Personal Pension, War Disability Pension, War Widows Pension, Unemployability Supplement, Allowance for Lowered Standard of Occupation*. Members and Widows should be aware that although the War Pension and the War Widows Pension are counted as income, the first £10 is disregarded. The pre-1973 War Widows Supplementary Pension is completely disregarded. The following allowances are disregarded completely: *Attendance Allowance, Disability Living Allowance (Care Component), Constant Attendance Allowance, Comforts Allowance, Mobility Allowances, Housing Benefit, Council Tax Benefit*. You may be more likely to receive the Pension Credit if you are a severely disabled person in receipt of one of the following allowances; *Attendance Allowance, Disability Living Allowance (Care Component), Constant Care Allowance*. Applications can be made over the telephone and your claim form filled in while you speak (it should not take longer than half an hour). You will require the following information: National Insurance Number and that of your spouse if claiming as a couple, Details of your income, Details of your savings. To apply over the 'phone call Freephone 0800 991234.

Motability Enhancements. On 1 October Motability unveiled more enhancements to the Motability Scheme bringing further benefits to their customers, improvements to their services and driving prices down. The changes include: Prices cut by up to £500 from all contract-hire leases. An increase to around 200 cars, including around nineteen automatics, available at nil advance payment on contract-hire. A single, local-rate customer services number: 0845 456 4566. A range of measures to help customers remain mobile between car agreement renewals or if their car is stolen or written-off. Introduction of an improved tyre service (from August 2003) where damaged tyres are replaced free of charge for contract-hire customers. Many of the improvements have been influenced by feedback they have received from customers and their commitment to reducing costs. Look out for full details in the autumn edition of Lifestyle magazine which will have more details or you can go to their website at www.motability.co.uk from October. **New Durashift Transmission.** Ford has also released details to customers and dealers about the new Durashift transmission, available for Ford Fiestas. Durashift enables drivers to switch between clutch-free manual control and intelligent automatic mode, providing hassle-free driving. **Soft-top or convertible?** Convertible cars will be available on the Motability contract hire scheme from November, making certain Motability continue to supply a choice of cars, which reflect the tastes, and lifestyles of their customers. Relevant insurance and excess terms will apply. Anyone interested in these cars should contact their accredited car dealer or Motability Operations from November for details. **New Customer Services Telephone Number.** From 1 October it will be easier to get in contact with Motability. If you are calling Motability, remember to dial their new customer services, telephone number 0845 456 4566. All calls are charged at local rates. **Adapted Vehicles.** If your contract hire car is heavily adapted, or is a wheelchair accessible vehicle, you will now be able to extend your contract up to five years.

Advice for Automatic Car Drivers: Motability's Contract Hire Price Guide has been updated to include an explanation on the differences between standard automatics, semi-automatics, and Continuously Variable Transmission (CVT) cars. We continue to receive calls from customers who have taken delivery of a CVT or semi-automatic car, and have found the driving experience of both types of car different to that of a standard automatic. In some cases, customers have found it difficult to drive these cars, and have requested an early termination of their agreement. The main concern for customers is that, when stationary, a CVT or semi-automatic car will roll backwards on a slope, unless the brakes are in use or the handbrake is on, whilst a standard automatic will not roll because it has a 'creep' facility. Some cars are now available with a 'Hill Start Assist System' which holds the brakes on for a short while, to enable a hill start. This may be suitable for some drivers. Customers should check with their dealers first to confirm whether the automatic car they have selected has a 'creep' facility. It is also important that customers have a test drive before ordering their new car, particularly if they are used to driving a standard automatic car. Please speak to your dealer or contact the manufacturer of your selected car for more information.

SCAM WARNING

The following warning (verified as genuine) has been received from Dorset Police about a VISA / MasterCard scam that is currently being perpetrated by telephone. Please take note.

Someone will call stating that they are from either VISA or MasterCard along the following lines: "This is (Any Name) and I'm calling from the Security and Fraud department at VISA / MasterCard. My Badge number is 12460 (they may give any number). Your card has been flagged for an unusual purchase pattern, and I'm calling to verify this. This would be on your VISA / MasterCard. Have you purchased an Anti-Telemarketing Device (or any other expensive item they may name) for £497.99 from a marketing company based in (Anywhere) recently?" When you reply "No", the caller continues with: "Then we will be issuing a credit to your account. This is a company we have been watching and the charges they are putting onto peoples accounts range from £297 to £497, ie: just under the £500 purchase pattern that flags up on most cards. Before your next statement, the credit will be sent to (*gives you your correct address*), is that correct?" When you say "Yes", the caller continues . . . "I will be starting a fraud investigation immediately. If you have any questions, you should call the 0800 number listed on your card 1-800-VISA and ask for Security. You will need to refer to this Control # ". They then give you a 6 digit number. The caller then says that they: ". need to verify that you are in possession of your card. Please turn the card over. You will see 7 numbers printed on the (signature strip). The first 4 are (1234 or whatever), the next 3 are the security numbers that verify you are in possession of the card. [These are the numbers you may sometimes use to make internet purchases to prove you have the card]. Could you please read me the 3 numbers." When you do, they say: "That is correct. I just needed to verify that the card had not been lost or stolen, and that you still have your card. Do you have any other questions? Don't hesitate to call back if you do." You have actually said very little, and they never ask for or tell you the card number. However, within 15 minutes the sum of £499.99 will have been debited from your card! What the scam requires is simply the 3 digit number and if the card is not stopped, they will keep charging an amount every few days. As you have given the number freely over the phone, filing the necessary fraud report at the end of the month when the statement comes will be extremely difficult. REMEMBER: THE REAL CARD ISSUERS WILL NEVER ASK FOR ANY DETAILS FROM YOUR CARD (THEY ALREADY HAVE THOSE) IF IT IS A GENUINE CALL, THEY WILL MERELY ASK YOU TO CONFIRM SECRET INFORMATION WHICH YOU PROVIDED WHEN YOU ESTABLISHED THE CARD IN THE FIRST PLACE. DO NOT REVEAL ANY OF YOUR CREDIT CARD DETAILS OVER THE PHONE TO SOMEONE WHO RINGS YOU

THE ROYAL HOSPITAL CHELSEA—INTO ITS FIFTH CENTURY

Few of those who watch the Royal British Legion's Festival of Remembrance each November can fail to be touched by the entry of the Chelsea Pensioners. The measured tones of 'The Boys of the Old Brigade' start as a contingent of scarlet clad old men slowly marches into the arena. These men are a national symbol that has come to represent tradition and service to the Crown. The Royal Hospital (meaning refuge or shelter) was founded in 1682 by Charles II for "the relief of veterans broken by age and war". Still located in the original buildings designed by Sir Christopher Wren it is the home to about 350 former soldiers, who served in the Second World War and now more recent campaigns. Admission as a Chelsea pensioner has always been highly prized. In the 18th Century anyone impersonating a Chelsea Pensioner could be sentenced to death or sent to the Colonies.

Today, to be eligible for admission as an In-Pensioner a candidate must be male and:-In receipt of a Service or Disability Pension awarded for Army Service, normally at least 65 years of age, and free from the obligation to support a wife or children. Applications are welcome at any time from any former soldier who is qualified. Currently, because of the accommodation available, it is not possible to admit women.

The Royal Hospital has always been organised on semi-military lines. Today the Governor is supported by the Lieutenant-Governor, the Secretary and nine heads of departments. Senior staff are mainly former regular Army officers or civil servants. Currently the In-Pensioners are organised into six companies under the care of a Captain of Invalids. Each Company has a Company Sergeant-Major and NCOs drawn from the In-Pensioners to assist in its running. Around 90 of the In-Pensioners work voluntarily as guides, chapel attendants, clerical, shop staff and museum attendants and in many other ways. They make a considerable contribution to the running of the Royal Hospital. On arrival each new In-Pensioner is given a Berth in one of the 18 Long Wards (which remain essentially as they were designed by Sir Christopher Wren) and is allocated to a Company. The In-Pensioner surrenders his Army pension(s) and in return receives board, lodging, clothing and full medical care. Depending on individual need support for each In-Pensioner ranges from sheltered housing, through all levels of nursing care to providing a hospice. In-Pensioners are encouraged to pursue a full and active life within the Royal Hospital. In addition to undertaking voluntary jobs In-Pensioners can enjoy many recreational pursuits including the use of a Club, amenity centre, television and snooker rooms, a library, an arts and craft centre, bowling and putting greens and allotment gardens. Trips are arranged regularly both within the United Kingdom and overseas, including Battlefield tours, to sporting events and visits to military establishments. In 2002 a party went to the White House in Washington and met the President. Parades are now mainly limited to Annual Founder's Day, and the Governor's Parade which takes place on Sunday morning before Chapel. The salute is taken by the Governor, Lieutenant Governor, Secretary or Adjutant with In-Pensioners from each Company on parade. Holidays and leave of absence is freely granted for up to six weeks at a time, although an In-Pensioner must be in residence for Founder's Day and rehearsals, which take place in early June. Within the confines of the Royal Hospital all In-Pensioners are encouraged to wear the Royal Hospital's informal uniform. On all official occasions they wear the famous scarlet coats, completed at ceremonial events by tricorne hats. This dress is a modernised version of the uniform worn at the beginning of the 18th century.

The Royal Hospital's Founder's Day is held on a day close to May 29th which is the birthday of King Charles II as well as the date of his restoration as King in May 1660. The Parade is normally reviewed by a member of the Royal Family. During the course of this celebratory day the statue of Charles II in Figure Court is shrouded in oak leaves, and all participants on the Parade and spectators wear sprigs of oak leaves. This commemorates the King's escape from the Parliamentary forces after the Battle of Worcester in 1651. The statue was re-gilded in 2002 to commemorate the Golden Jubilee of Queen Elizabeth II. The Royal Hospital has always been proud to have a close link with the Sovereign. This continues strongly into the 21st Century. Her Majesty Queen Elizabeth II has reviewed the In-Pensioners on Founder's Day on four occasions. The most significant Royal event in recent years occurred on 5th July 2002 when Her Majesty reviewed the Pensioners at Buckingham Palace and presented The Royal Hospital with its first 'colours', The Sovereign's Mace. The Royal Hospital is now taking steps to ensure that it can continue to provide the most modern residential accommodation and care, yet maintain the fabric of the buildings and tradition of the past. This will require: A new Infirmary building, Improved accommodation in the Long Wards and better facilities for the In-Pensioners, also to allow women to be admitted, and Improvements to the grounds to maintain the quality of life and make it a pleasant place to live, work and visit. Chelsea Pensioners are proud to continue a way of life and traditions established over five centuries. The Royal Hospital is committed to provide high quality residential care for old soldiers that have served their country loyally in both war and peace.

NEW SCHEME FOR GIVING TO CHARITY THROUGH THE TAX RETURN

From April 2004 people who complete a Self Assessment tax return will be able to nominate a charity to receive all or part of any repayment due to them. The Inland Revenue repaid around £3 billion to nearly 3 million Self Assessment taxpayers last year. The new scheme will have real advantages for participating charities:

The donation will be paid direct to the charity's bank account. The form will incorporate a Gift Aid declaration. Gift Aid tax will be paid without the charity having to make a claim. For the first time charities will benefit from Gift Aid on anonymous donations.

Please remember that this method of giving will not be available until the Self-Assessment returns are issued in **April 2004**. Should you wish to donate using this scheme, the details are 'The Royal Dragoon Guards Regimental Association' and our unique code is **NAL17FG**.

Commemorative Medal

A New Commemorative Medal has been struck to recognise the Active Service of British and Commonwealth Forces from WW11 to the present Day. The Medal is called "The Active Service Medal". It is of standard size and is Gold Plated. Anyone who has done Active Service will qualify for this Medal, however serving Personnel should not wear this Medal in Uniform but may do so upon becoming Civilians. Funds will be raised for SSAFA Forces Help from sales of these Medals. What better cause is there for Ex and serving Personnel of Her Majesty's Armed Forces.

THE BRITISH FRIENDS OF NORMANDY

After the Allied landings of D-Day, 6 June 1944 and the consolidation of the bridge-head, Caen became the anvil of the Battle of Normandy. General Montgomery's objective was to draw the Germans onto his sector of the battlefield so that the American forces to the West could extend and expand; as a result of the fierce battle, the City of Caen was virtually destroyed, some 15,000 inhabitants in the region were killed. The Battle for Normandy raged for some 80 days with about three million men engaged, of whom 300,000 lost their lives.

The 2nd Battalion of the Royal Ulster Rifles was the first to enter Caen and, with the Canadians, liberated the city. Their commanding officer was the late Lieutenant General Sir Ian Harris KBE CB DSO.

When the City of Caen decided to build a magnificent Museum - the Memorial of the battle of Normandy, it was dedicated, not to war, but to peace. International support was given to the Museum, especially by America and Canada. There was some concern, however, that the British contribution in the Battle for Normandy and, in particular, the liberation of Caen, should not be overshadowed. General Harris therefore initiated the British Support Committee which resulted in many suitable artefacts and records being obtained to demonstrate the role played by the British Forces. During the operations in Normandy General Harris met, and subsequently married, a French lady - Anne-Marie Desmontreux, and Lady Harris has worked tirelessly to promote the British contribution. Having provided the initial British presence in the Museum, the support committee turned its attention to the idea of a British Memorial Garden adjacent to the Museum. This involved much detailed discussion with the Caen authorities in which Lady Harris had taken the lead. General Harris wished very much that the Garden should represent not only those involved in the liberation of Caen, but also all those in Her Majesty's Forces and civilians who were concerned with the war effort. With the help of Mr Reg Maxwell, lately the Director of the Botanical Gardens in Belfast, a beautiful garden has been designed and work is underway. It is intended that a formal opening will coincide with the 60th anniversary of D-Day in June 2004.

The Garden, alongside the Museum, is about the size of a rugby pitch and the use of the ground has been granted on a long-term arrangement with the Caen authorities. The centrepiece is a Fountain of Spirits commemorating all those who lost their lives. Along the side will stand the emblems of the British and Allied divisions and formations involved, together with, a naval and RAF memorial, the latter being a solid granite block from the Mountains of Mourne. There will be a Peace Garden providing an area for quiet contemplation.

There is easy access from the Museum car parks and it is overlooked by a recent extension to the Museum. The Caen authorities have been most helpful with the siting and preparation of the ground for the British Garden.

FIRE FIGHTING DUTIES

Readers will recall that the Regiment was extensively used during the firefighters strike in 2002 and 2003. It may be of interest to know that this was not the first time that fire fighting duties have been performed by our predecessor Regiments. In 1829 it was the 7th Dragoon Guards in York and in 1857 the 5th Dragoon Guards in Edinburgh.

The 7th Dragoon Guards distinguished themselves in the role of firemen in 1829. In the early hours of 2nd February 1829, one Jonathan Martin, described as 'a lunatic', started a fire in the organ loft of York Minster, and by 7 o'clock the whole of the roof was ablaze. The City's appliances, and those of the Yorkshire Insurance Company, galloped up soon afterwards, but as their combined efforts proved unavailing, 'an express was also sent to the barracks, and the barrack engine arrived at about 8 o'clock, accompanied by Major Clark, several officers and a file of the 7th Dragoon Guards' (in fact, four whole Troops were despatched). The blaze was finally brought under control by late afternoon, with officers and troops manning pumps and hoses and salvaging furniture and treasures. But by this time the historic Minster had been severely damaged, with the roof of the centre aisle collapsed, all interior woodwork, including the fine altar screen and choir stalls, reduced to ashes, and many of the monuments destroyed. The exertions of the Regiment were officially recognised at a meeting of the Dean and Chapter on 10th February 1829: **Resolved unanimously**, 'That the most grateful thanks of the Chapter be offered to Major Clark, the Officers and Privates of the Seventh Regiment of Dragoon Guards for their valuable services at the time of the conflagration in York Minster'.

To compliment so distinguished a Regiment as the Seventh Dragoon Guards upon its order and discipline would be superfluous and nugatory; but it may truly be remarked that there never was an occasion when order and discipline were more conspicuous, or more useful, than in the conduct of the 7th Regiment on the awful Second of February. Seven days after helping fight this fire, Troop Sgt Maj John Polety died and a Memorial stone to the Polety brothers occupies a place of honour in the All Saints, Pavement which is of course our Regimental Church.

5th Dragoon Guards: In August 1857, a serious fire broke out in the Old Town of Edinburgh, and although it was some distance from Pierhill Barracks, the Regiment was early at the scene of conflagration, and was very instrumental in subduing it, and in rendering aid for the preservation of order and the protection of property. The following is a copy of a letter from the Lord Provost, conveying the thanks of the Magistrates and Town Council, to the Regiment for its services on the occasion.

Edinburgh 11 August 1857

Sir

I have the honour to convey a Resolution unanimously adopted by the Magistrates and Town Council of the City at their meeting today, to express their warm and cordial thanks to the Officers and Men of your Regiment for the valuable and effective aid rendered by you in extinguishing the late fire, and in preserving order.
