## Autumn 2010

In a break from the norm this newsletter will not have any Commanding Officer's notes. These will appear in a later newsletter once the Regiment is safely back in Catterick.

This newsletter is early so as to ensure that everyone gets the information regarding the post tour event. You will also find information regarding next year's Oates Parade, which will be held in York, and the usual return for Cavalry Memorial parade in May 2011.

### **Memorial Service, Medal Parade and Lunch 2 December 2010**

The Medal Parade, Memorial Drum Head Service and lunch will take place on Thursday 2 December at 11:00am at the Race Course in York. The Regiment and their families will all be there and it is hoped as many members of the Association as possible will join them. It will be very much a family affair, General Henry Woods as President of the Association will take the salute and present the Regiment with their Afghanistan medals together with The Colonel of The Regiment and The Commanding Officer, this will be followed by a Drum Head Memorial service for those who lost their lives during the tour. Lunch will be a buffet affair in one of the Race Course's many function rooms. Should there be a demand, it is planned to hold a cocktail party in the museum on the evening of Wednesday 1 December from 6:00pm to 8:00pm, this will give everyone a chance to look around the museum as well as catch up.

### **Oates Sunday 13 March 2011**

A decision was taken by the committee to move the annual Oates Service from London to York in the hope that it will attract more members of the Association. The parade and church service will take place in our own Regimental Church, All Saints, Pavement in York commencing at 12:30pm followed by a buffet lunch in the Hilton Hotel, which is next door to HHQ, the museum will also be open for those who wish to browse after lunch. The cost of lunch will be £10 per head.

## **Combined Cavalry Memorial Parade 8 May 2011**

The Combined Cavalry memorial Parade will take place in Hyde Park on Sunday 8 May 2011. Everyone is asked to be in the park by 10:30 am. This will be followed by a buffet lunch in The Victory Services Club. The turnout for 2010 was superb and given the recent losses in Afghanistan it is hoped that this will be repeated as a gesture of support to the bereaved families, not just our own but from other Cavalry and RTR regiments. The cost of lunch will be £10 per head.

It has served to bring more and more people back into the fold and, fact, we have the largest Regimental Association in Royal Armoured Corps and I suspect, beyond. The returns are inside and if they could be back in good time together with any remittance to allow HHQ to book meals etc, that would be very much appreciated.

## **Inheritance Tax Exemptions for Veterans**

Under s154 of the Inheritance Tax Act, the Joint Casualty and Compassionate Centre (JCCC), part of the Service Personnel and Veterans Agency, can grant exemptions from Inheritance Tax (IHT) on the estate of serving military personnel who die whilst on active service against the enemy or other service of a war like nature. Exemptions can also be granted on the estate of those who die in retirement where it can be shown that their death was due to or hastened by an injury or illness sustained on, or aggravated by, past military service that meets the requirements of the Act, even if the death occurs many years later. However, there is no automatic exemption for serving military personnel, or veterans, and the award of a war pension is no guarantee an IHT exemption will also be granted. Each case has to be considered on its merits after the death of the individual concerned and in the case of those dying in retirement will require the JCCC's medical advisors to be given access to the deceased full medical history. Further information on IHT exemptions can be obtained from the Deceased Estates Office of the JCCC.
